Superintendent Rick Spicuzza shared good news from around the district and community.

Superintendent Spicuzza shared an overview of the District and current standings. Highlighting the current challenges that continue to be monitored: recruitment and retention of staff, aging of facilities, energy efficiency & cost avoidance to operate all facilities and maintain a balanced budget.

<u>RESOLUTION C – REIMBURSEMENT OF BOARD MEMBERS' EXPENSES:</u> Motion by Jim Reichert, seconded by Josh Fiege that school board members are reimbursed for actual expenses (out of district) in conducting the business of the Board of Education. Motion carried.

<u>SET ANNUAL MEETING DATE</u>: Motion by Steve Block, seconded by Steve Sizemore to allow the school board to set a date & time for the 2020 Annual Board Meeting. Motion carried.
